LA Fires: Renewal Fee Postponement

On January 29, 2025, Governor Gavin Newsom issued Executive Order N-15-25, granting a one-year postponement of license renewal fees for Department of Consumer Affairs licensees whose licenses expire between January 1, 2025, and June 30, 2025, and whose residences or businesses fall within designated wildfire-impacted zip codes.

Licensees that live or work in one of the impacted zip codes and have a license expiring during the affected timeframe may renew their license without paying the renewal fee. Note: The fee is not waived; it is only postponed until 2026.

The impacted zip codes are 90041, 90049, 90265, 90272, 90290, 90402, 91001, 91024, 91103, 91104, 91107, 91367, and 93536.

Important Reminders:

- Licensees must still complete the renewal application on time, even if no fee is due.
- The renewal fees will be postponed until 2026.
- The renewal system will automatically recognize eligible licensees and reflect a \$0 payment due during the renewal.

Help Shape the Landscape Architect California Supplemental Exam

LATC is seeking dedicated and qualified licensed landscape architects to serve as Subject Matter Experts (SMEs) for the development of the California Supplemental Exam (CSE). SMEs selected to participate will receive a \$200 honorarium and reimbursement for all board-approved travel expenses.

To ensure the CSE accurately reflects current professional practice, SMEs will participate in two-day examination development workshops held virtually or in Sacramento. These workshops are critical to maintaining the integrity and relevance of the licensing process. Participants will engage in activities such as writing and refining test questions, reviewing content for clarity and accuracy, and contributing to the standard-setting process that determines passing scores.

Qualified SMEs must meet the following criteria:

- Hold a current and active California landscape architect license (not retired).
- Be actively working in the profession with up-to-date knowledge and experience.
- Not currently serving as a member of a board, bureau, or committee, to avoid potential conflicts of interest.

LATC aims to assemble a group that reflects the diversity of the profession—taking into consideration geographic region, practice specialty, ethnicity, and gender to ensure a well-rounded and inclusive examination development process.

If you are a licensed professional who is passionate about contributing to the future of the landscape architecture profession in California, LATC encourages you to get involved.

Frequently Asked Questions

Each newsletter will feature answers to some of the most common questions received from license candidates. This section is designed to provide helpful guidance, clarify application and examination procedures, and provide support throughout the application and licensure process.

Q. I have submitted my application. Can you confirm I did not miss anything?

A. If any information or documentation is missing or requires clarification, the Licensing and Exam Coordinator will contact candidates directly. To help avoid delays, be sure to review the application requirements carefully before submitting your materials. LATC appreciates your patience as each application is reviewed thoroughly in the order received.

Q. What is the process for a candidate with a degree from outside the United States?

A. Candidates with international education must meet the same requirements as all other candidates. These include:

- Submission of verified academic credentials
- Documentation of qualifying education and experience
- Completion of the California Supplemental Examination (CSE)
- Passing scores on the Landscape Architect Registration Examination (LARE)

To determine whether your degree meets California's educational requirements, LATC requires an evaluation. Candidates who received their education at colleges and universities outside the United States may be eligible to take the LARE. Candidates must submit a credential evaluation report, which includes information about the candidate's credential (diploma or degree) and its US equivalent. These reports are prepared by credential evaluation services after examining the candidate's education documentation for accuracy and authenticity. Although these companies typically offer several levels of evaluation, LATC only requires a "general" evaluation equating the degree to a comparable US degree in landscape architecture. The fees associated with obtaining a credential evaluation are the candidate's responsibility.

Upon receipt of the required documentation, the LATC Licensing and Exam Coordinator will conduct a review to determine if the candidate is eligible. The credential evaluation report is used to determine if the candidate has received an education that meets LATC's established requirements. Candidates will receive written notification regarding determination of eligibility.

Q. What is the application processing time?

A. Please allow up to 45 days for LATC to process your application after it is received.

Q. What should I do if I forgot to attach something to my application?

A. If you realize that you forgot to include a required item with your application, and your application has already been evaluated, and you've received communication from the Licensing and Exam Coordinator via the Connect portal, upload the missing item(s) directly to your Connect application. The item(s) will then be attached to your existing application. If your application has not yet been evaluated, email the item(s) to LATC@dca.ca.gov, and the Licensing and Exam Coordinator will ensure everything is added to your application prior to the review.

Q. How do I get hard cards for fingerprints mailed to me?

A. Submit your fingerprint hard card request using the 'Contact Us' form at www.latc.ca.gov. Within three to four weeks, you will receive two FD258 hard cards, a copy of the privacy notices, a fee schedule, and instructions for printing and returning the cards to LATC. You will be required to submit a check or money order for the fingerprint card processing fee, currently \$49 (\$32 for the Department of Justice, \$17 for the FBI), when you return the cards to LATC.

Final Citations

Michelle Langdon (La Mesa) – LATC issued a two-count citation with a \$500 administrative fine to Michelle Langdon, an unlicensed person, for alleged violations of Business and Professions Code sections 5640 and 5641.

On or about October 5, 2023, a licensed landscape architect received a set of plans in PDF format to review from a homeowners association in Poway, California. The plans were produced by Michelle Langdon, who is not a licensed landscape architect. The complainant, a licensed landscape architect, alleged that the plans provided way more details than a landscape designer is allowed to do.

Among its services, Langdon's website offers "full landscape concept plans" that include hardscape plans (elements such as patios, outdoor kitchens, pools, spas, etc.).



On the landscape concept plans for the Poway project, Langdon provides the following: exact quantities of materials and directions for how to install the tile material; physical dimensions, which are more consistent with construction drawings; and very precise and detailed linework and callout information for a BBQ and overhead trellis structure. Langdon's preparation of conceptual plans with exact quantities of materials and installation directions, physical dimensions, and precise detailed linework with callout information for a structure constitutes a violation of Business and Professions Code section 5641. Langdon's company LinkedIn profile indicates it offers "Landscape Architecture" services under "Specialties," indicating to the public that she is a landscape architect or qualified to engage in the practice of landscape architecture and constituting a violation of Business and Professions Code section 5640. The citation became final on October 6, 2024, but LATC has not been able to collect the funds.

Navigating Connect

Learn About the New Online Licensure System

Your Step-by-Step Guide to Getting Started

Welcome to the “Navigating Connect” series, created to guide future landscape architects through LATC’s new online application portal, Connect. Whether you are just starting the journey or seeking licensure by reciprocity, this series will help make the process smooth and clear.

LATC transitioned to the Connect platform in May 2023, giving candidates and licensees a streamlined way to:

- Apply for eligibility for the Landscape Architect Registration Examination (LARE)
- Apply for the California Supplemental Examination (CSE)
- Apply for or renew a California landscape architect license
- Apply for reciprocity

Step 1: Create Your Connect Account

Start by visiting <https://connect.latc.ca.gov>.

- Register by entering your email address. This will also be your username.
- Double-check for typos! This is critical. If your email address is incorrect, you won’t receive a temporary password to log in.
- After registering, look out for a confirmation email from Connect with your temporary password to log in. This will be emailed immediately after registering. Check your spam or junk folder if you do not see the email.
- Log in using your email and temporary password.
- Change your password when prompted.
- Once your password is updated, you will arrive at your Connect dashboard.

Step 2: Submit Your Application

Once you are registered, it's time to apply.

- If you are new to the licensure process, complete the Eligibility Application to be found eligible to sit for the LARE exam.
- If you have passed all sections of the LARE, complete the California Supplemental Examination (CSE) Application.
- Once you have passed both the LARE and the CSE, complete the Initial License Application.
- If you are already licensed in another state, complete the Reciprocity Application.

It is important to note that only one application should be submitted at a time, and a candidate should not move on to the next application until they receive approval from LATC through their Connect portal.

Also, official transcripts sent to LATC must be sent by the educational institution to the LATC email:

Step 3: Pay and Submit

After completing your application, you will be directed to the payment screen.

- Confirm you have selected the correct application and fee.
- Enter your payment details and submit.
- You will receive a confirmation email once payment is complete and your application has been submitted.

Please allow 6-8 weeks for review. LATC will notify you via email if you are eligible to move forward with scheduling an examination or if there is a deficiency in your application.

You can track your application status anytime through your Connect dashboard.
