#### California Code of Regulations, Title 16, Division 26

Amend Section 2649 as follows:

#### § 2649. Fees.

The fees for landscape architect applicants and landscape architect licensees shall be fixed by the Board as follows:

- (a) The application fee for reviewing an applicant's eligibility application or an application to take any section of the <u>national licensing</u> examination or the <u>California Supplemental</u> Examination, commencing with the 1999 examination and thereafter, is \$35.
