# CALIFORNIA ARCHITECTS BOARD LANDSCAPE ARCHITECTS TECHNICAL COMMITTEE FINAL STATEMENT OF REASONS

Hearing Date: May 12, 2014

Subject Matter of Proposed Regulation: **Application for Examination** 

Section Affected: California Code of Regulations (CCR), Title 16, Division 26, Section 2610

### **Updated Information**

The Initial Statement of Reasons is included in the file. The information contained therein is updated to correct the following sentence found in the "Anticipated benefits from this regulatory action" section:

"This proposal would increase the amount of time that candidates have to apply for the Landscape Architects Registration Examination and change the registration deadline to be consistent with the Landscape Architect Technical Committee's current application processing timeframe."

The word "increase" should be "decrease." The word "increase" was used incorrectly and was meant to convey that this proposed regulatory change would allow candidates to file their application with the Landscape Architects Technical Committee (LATC) closer to the date of the next administration of the Landscape Architects Registration Examination. Instead of submitting the application and fees to the LATC at least 70 days prior to an exam, that timeframe would be decreased, allowing candidates to send the application and fees to the LATC at least 45 days prior to the next exam.

In addition, the Notice of Proposed Changes in the Regulations document is updated to correct the following sentence found in the "Anticipated Benefits of Proposal" section:

"This proposal would increase the amount of time that candidates have to apply for the LARE and change the registration deadline to be consistent with LATC's current application processing timeframe."

The word "increase" should be "decrease." The use of the word "increase" was used incorrectly and was meant to convey that this proposed regulatory change would allow candidates to file their application with the Landscape Architects Technical Committee (LATC) closer to the date of the next administration of the Landscape Architects Registration Examination. Instead of submitting the application and fees to the LATC at least 70 days prior to an exam, that timeframe would be decreased, allowing candidates to send the application and fees to the LATC at least 45 days prior to the next exam.

These corrections do not affect the purpose or scope of the proposed regulatory change.

#### Local Mandate

# Anticipated Benefits of This Regulatory Action

This proposal would decrease the amount of time that candidates have to apply for the Landscape Architects Registration Examination and change the registration deadline to be consistent with the Landscape Architects Technical Committee's current application processing timeframe. This proposal also has the potential to expedite the pathway to licensure for prospective licensees.

### Consideration of Alternatives
