FINAL STATEMENT OF REASONS

Hearing Date: **November 30, 2016**

Subject Matter of Proposed Regulation: **Fees**

Section Affected: **California Code of Regulations (CCR), Title 16, Division 26, Section 2649**

Updated Information

The Initial Statement of Reasons is included in the file. The information contained therein is updated as follows:

At the end of Fiscal Year 2015-16, the Landscape Architects Technical Committee (LATC) had 27.4 months of funds in reserve.

Edits were made to correct a typographical error found in the language pertaining to Business and Professions Code reference section 5650; it was changed to section 5681. No modified text was issued for this change as it is a change without regulatory effect.

Local Mandate

A mandate is not imposed on local agencies or school districts.

Small Business Impact

The Board has determined that the proposed regulation would affect small businesses by lowering the cost of maintaining their licenses.

Anticipated Benefits of This Regulatory Action

The LATC proposes to extend the temporary reduction in license renewal fees to ensure compliance with existing law. Licensees would also benefit from the temporary license renewal fee reduction by lowering the cost of maintaining their licenses.

Consideration of Alternatives

The Board has determined that no reasonable alternative it considered to the regulation or that has otherwise been identified and brought to its attention would be more effective in carrying out the purpose for which the action is proposed, would be as effective and less burdensome to affected private persons than the proposal described in this Notice, or would be more cost effective to affected private persons and equally effective in implementing the statutory policy or other provision of law.
