Amend Section 2649 in Article 1 of Division 26 of Title 16 of the California Code of Regulations to read as follows:

§ 2649. Fees

The fees for landscape architect applicants and landscape architect licensees shall be fixed by the Board as follows:

- (a) The fee for reviewing an eligibility application or an application to take the California Supplemental Examination is \$35100.
- (b) The fee for the California Supplemental Examination is \$275350.
- (c) The fee for a duplicate license is \$45300.
- (d) The penalty for late notification of a change of address is \$50.
- (e) The fee for an original license is \$400700.
- (f) For licenses expiring on-or after July 1, 2009, the fee for biennial renewal shall be \$400. For licenses expiring on or after July 1, 2015, the fee for biennial renewal shall be \$220. For licenses expiring on or after July 1, 2019, the The fee for biennial license renewal shall-be \$400700.
